



## DATA PRIVACY NOTICE

### The Parochial Church Council (PCC) of Christ Church, St Albans

#### 1. Your personal data – what is it?

Personal data relates to a living individual who can be identified from that data. Identification can be by the information alone or in conjunction with any other information in the data controller's possession or likely to come into such possession. The processing of personal data is governed by the General Data Protection Regulation (the "GDPR").

#### 2. Who are we?

The PCC of Christ Church, St Albans is the data controller (contact details below). This means it decides how your personal data is processed and for what purposes.

#### 3. How do we process your personal data?

The PCC of Christ Church, St Albans complies with its obligations under the "GDPR" by keeping personal data up to date; by storing it securely and, when appropriate, destroying it securely; by not collecting or retaining excessive amounts of data; by protecting personal data from loss, misuse, unauthorised access and disclosure and by ensuring that appropriate technical measures are in place to protect personal data.

We use your personal data for the following purposes: -

- To enable us to provide a voluntary service for the benefit of the public in the particular geographical area as specified in our constitution;
- To administer membership records;
- To fundraise and promote the interests of the charity;
- To manage our employees and volunteers;
- To maintain our own accounts and records (including the processing of gift aid applications);
- To inform you of news, events, activities and services which are run at or by Christ Church;
- To contact individuals via surveys, to conduct research about their opinions of current activities or of potential new activities that may be offered;
- To share contact details of Church post-holders with the Diocesan and Deanery offices so that they can be informed about news in the diocese and deanery and about events, activities and services that will be occurring in the diocese and deanery and in which they may be interested.

#### 4. What is the legal basis for processing your personal data?

The relevant legal bases for the PCC to process information are:

- Where explicit consent of the data subject is given so that we can keep you informed about news, events, activities and services, process your gift aid donations, and keep you informed about Church related matters;
- Where processing is necessary for carrying out obligations under employment, social security or social protection law;
- Where processing is carried out by a not-for-profit body with a religious aim, such as ourselves, provided: -
  - the processing relates only to members or former members of Christ Church (or those who have regular contact with it in connection with those purposes); and
  - there is no disclosure to a third party without consent.

## 5. Sharing your personal data

Your personal data will be treated as strictly confidential and will only be shared with other members of the church in order to carry out a service to you or to other church members or for purposes connected with the church. We will only share your data with non-Church members with your consent.

## 6. How long do we keep your personal data<sup>1</sup>?

We keep data in accordance with the guidance set out in the guide “Keep or Bin: Care of Your Parish Records” which is available from the Church of England website [see footnote for link].

Specifically, we retain electoral roll data while it is still current; gift aid declarations and associated paperwork for up to 6 years after the latest calendar year to which they have relevance; and parish registers (baptisms, marriages, funerals) permanently.

## 7. Your rights and your personal data

Unless subject to an exemption under the GDPR, you have the following rights with respect to your personal data: -

- The right to request a copy of your personal data which the PCC of Christ Church, St Albans holds about you;
- The right to request that the PCC of Christ Church, St Albans corrects any personal data if it is found to be inaccurate or out of date;
- The right to request your personal data is erased where it is no longer necessary for the PCC of Christ Church, St Albans to retain such data;
- The right to withdraw your consent to the processing at any time
- The right to request that the data controller provide the data subject with his/her personal data and where possible, to transmit that data directly to another data controller (known as the right to data portability), (where applicable);
- The right, where there is a dispute in relation to the accuracy or processing of your personal data, to request a restriction is placed on further processing;
- The right to object to the processing of personal data (where applicable)
- The right to lodge a complaint with the Information Commissioners Office.

## 8. Further processing

If we wish to use your personal data for a new purpose, not covered by this Data Protection Notice, then we will provide you with a new notice explaining this new use prior to commencing the processing and setting out the relevant purposes and processing conditions. Where and whenever necessary, we will seek your prior consent to the new processing.
